**PRESENT:**

Mayor Kerr, Trustee Fredrickson, Trustee Mosher, Trustee Killock Trustee Rupp, Village Clerk, Lisa Rizzo

**CALL TO ORDER:**

Mayor Kerr called the meeting to order at 7:00. The Pledge of Allegiance.

**MINUTES:**

Copies of the minutes from the last regular meeting June 10, 2020 were given to the board. Motion to accept minutes made by Trustee Killock and seconded by Trustee Mosher. Carried.

**TREASURER'S REPORT / ABSTRACT REPORT:**

Copies of the monthly report for June,2020 were handed out to the Board members, the abstracts for May,2020 were presented to the board to be signed. Trustee Rupp made a motion to accept the abstracts, Trustee Mosher second and the motion was carried. Kudos to Linda, Jon, & Matty for a terrific job with Music in the Park. The Music in the Park and the Library are now being reported to the state, as they weren't being reported in the past. Cattaraugus Co. Civil Service has asked for reporting from Jan. till present and it is complete. The office would like the garbage slips turned in weekly and timesheets on time.

**CLERKS REPORT:**

All bank statements are reconciled for the month of June. The Village has collected around \$98,000 worth of Village taxes since June.

There will be smoke testing done in the Village for the EPG Grant.

There were 37 unpaid water/sewer bills as of July. The testing of Code Red went very well. The new date for Village elections is Sept.15,2020.

**TRUSTEE FREDRICKSON:**

There are 2 large holes in the park by the gazebo that needs filled in, before someone gets hurt. Disappointed in the millings that were put down in the parking lot across from the Depot. There are weeds growing in them, The gentleman running the kettle corn has another vendor that would like to set up also, for mobility scooters. The fire table is doing very well, we are selling a lot of tickets.

**TRUSTEE MOSHER:**

Concern over the safety while taking down the flags, it is dangerous, unsafe and not compliant to stand in a bucket and take flags down in the Village.

**TRUSTEE RUPP:**

Myself, Rob and the DPW crew put up the basketball backboards and hoops. A discussion about taking down the trees over the water tank down. I will be getting a quote for the job.

**TRUSTEE KILLOCK:**

Bulk trash will be July 27 & 28<sup>th</sup>. I am looking into the purchase of a new dump trailer for trash ect. Also looking into snow plows for the new Village truck. Complaints on people not using Village bags for their garbage. Complaints about Jim taking the truck home and the time of day that he is ending his work day.

Trustee Killock made a motion for the purchase of a time clock for the DPW, Trustee Rupp seconded the motion, all in favor with a 4 yes - 0 no. The motion was carried. Also, a mention to the office to be compliant with the Covid -19 preparation, suggested plexiglass at the clerk's desk.

**MAYORS REPORT:**

The Mayor presented to the Board the agreement for the USDA grant.

Bulk trash is the 27<sup>th</sup> and 28<sup>th</sup> of July.

The next regular meeting will be Thursday August 12, 2020 at 7:00 P.M. in the Library.

Trustee Killock moved to adjourn the meeting. Trustee Mosher seconded the motion, Carried. The meeting adjourned at 9:00 PM.
